







ADHESIVE IN WATER DISPERSION FOR BONDING FA-BRIC AND GLASS FIBRE WALL COVERINGS





PRODUCT DESCRIPTION

V 3500 is white, non-flammable, ready-to-use, water dispersion adhesive for bonding fabric and glass fiber wall coverings

FIELD OF APPLICATION

- · For bonding on walls and ceiling glass fiber mesh
- · For bonding on walls and ceiling non-woven fabric

LIMITATIONS

- · Not to be used at temperatures below 10°C.

- · Not to be used on a metal substrate.
- · Not to be used on tiles or other non-absorbent surfaces.

APPLICATION PROCEDURE

a) Preparation of the support

The substrates must be cured and sufficiently dry, mechanically strong, free from loose particles, grease, oils, paint, wax, etc. During spring and summer, renders must be cured for at least one week for every centimeter of thickness, unless they have been made with DCI special binders for walls. Gypsum substrates must be perfectly dry (max. residual moisture 0.5%), sufficiently hard, and dust-free. They must be treated with Primer Seal. It is not recommended to apply adhesive on substrates until hydraulic shrinkage is complete and the substrate has residual humidity lower than 4%

b) Preparing the product

V 3500 ready to be used.

c) Applying the product

Mix the adhesive before use if necessary. Spread the adhesive on the surface with a roller. When bonding heavy mesh or fabric, it is better to apply the adhesive with a fine notched trowell. Lay the mesh or nonwoven fabric on the fresh adhesive while the adhesive is still fresh and carefully place the mesh. Wait 24 hours before painting.



COVERAGE / CONSUMPTION

Approximately 0.1-0.25 kg/m² depending on dilution and application techniques.

V 3500 is supplied in:

- 20 kg plastic bucket.
- 5 kg plastic bucket.

SHELF LIFE

Original sealed packaging of this product is guaranteed to be of first quality for 24 months if stored in a dry area. In places with high humidity, the shelf life of the bagged product will be reduced.
